THE VICTIM OBSERVED THE DEFENDANT AND CO-DEFENDANT EXITING THE VEHICLE AND APPROACHING HER FRONT DOOR. THE LEFT SLIDING GLASS DOOR.

ON THE SURVEILLANCE CAMERAS THE VICTIM STATED THAT BOTH DEFENDANTS WERE INSIDE THE RESIDENCE RUMMAGING THROUGH THEIR PERSONAL PROPERTY. THE DEFENDANTS REMOVED PERSONAL PROPERTY WHICH INCLUDED TWO FIREARMS, GAMING CONTROLLERS, CELL PHONES, AND LAPTOP WHICH WERE PLACED ON THE SOUTH SIDE OF THE RESIDENCE WHICH WERE PLACED STRATEGICALLY TO BE LOADED INTO THE SUSPECT VEHICLE.

I THEN MADE EYE CONTACT WITH THE DEFENDANT WHO WAS ON THE SOUTH SIDE OF THE PROPERTY BEHIND AN ENCLOSED FENCE. THROUGH THE FENCE THE DEFENDANT OBSERVED ME IN FULL POLICE UNIFORM AND FLED ON FOOT EASTBOUND THROUGH THE BACKYARD, INTO AN ALLEY. I THEN INITIATED IN A FOOT PURSUIT AND YELLED AT THE DEFENDANT "POLICE, STOP RUNNING." THE DEFENDANT DISREGARDED MY VERBAL COMMANDS AND CONTINUED RUNNING SOUTH BOUND WHERE I BELIEVED THE SUSPECT WAS HIDING IN A SHED.

K-9 OFFICER WILSON AND K-9 "DUKE" RESPONDED TO THE SCENE. UPON ENTERING THE SHED BAKER WAS SQUATTING, WITH HIS LEFT HAND CONCEALED AROUND THE WAISTBAND AREA OF HIS PANTS. DUE TO THE FACT THAT THE SUBJECT MAY BE ARMED, BECAUSE HE KEPT HIS LEFT HAND CONCEALED, DUKE WAS RELEASED TO APPREHEND THE SUBJECT. BAKER THEN KICKED DUKE TWICE IN THE HEAD IN MY PRESENCE. DUKE THEN RELEASED HIS BITE FROM THE LEG AND BIT THE SUBJECT ON THE RIGHT FOREARM. DUKE THEN DRAGGED BAKER OUT OF THE SHED AND BAKER WAS PLACED UNDER ARREST.
