ON THE ABOVE DATE AND TIME, PATROL UNITS WERE DISPATCHED TO A BURGLARY IN PROGRESS LOCATED AT 15131 NE 13 AVENUE. THE HOMEOWNER/VICTIM ADVISED THAT FROM HER CELL PHONE VIDEO SURVEILLANCE SYSTEM, SHE OBSERVED A SUSPICIOUS BLACK FOUR-DOOR VEHICLE PARKED IN HER DRIVEWAY. THE VICTIM OBSERVED THE DEFENDANT AND CO-DEFENDANT EXITING THE VEHICLE AND APPROACHING HER FRONT DOOR.
