COMPLAINT FOR DEFAMATION PER SE

Plaintiff Amit Raizada ("Raizada" or "Plaintiff"), by and through his attorneys of record, sues Defendant Echo Fox, LP ("Echo Fox" or "Defendant"), and states:

NATURE OF THE ACTION

- 1. In 2015, Urlich "Rick" Fox ("Fox"), a close and longtime friend of Amit Raizada, and others partnered to become owners of a professional eSports organization in Riot Games' League of Legends Championship Series ("LCS"), which ultimately became Echo Fox. Raizada and the others handled the business, investment, and operations side of Echo Fox; Fox served as brand ambassador, allowing the team to use his name, likeness, and sports fame to market, promote, and assist Echo Fox's growth and development.
- 2. In October of 2018, Fox acquired an ultimate controlling interest in and became the indirect manager of Esports, LLC ("Esports"), which was the General Partner of Echo Fox, for \$10 million. Fox personally guaranteed \$2.5 million of that purchase price. On October 23, 2018, the day after Fox took control of Defendant, Forbes valued Echo Fox at \$150 million. Less than a year later, Echo Fox was worth less than \$30 million.
 - 3. Shortly after taking control of Defendant, Fox sought to abandon Echo Fox and

Esports and escape the \$2.5 million of debt he personally owed under the October 2018 deal. Fox offered to trade his ownership in Defendant and Esports to Raizada for Raizada's ownership in another company, which Raizada declined. Thereafter, Fox, while acting in the course and scope of his authority for Defendant, engaged in a variety of actions designed to harm Raizada, both professionally and personally. Among other things, Fox gave interviews and participated in podcasts with various news agencies, publications, broadcasters and other media outlets, making false and defamatory statements about Raizada while acting in the course and scope of his authority for Defendant, including, publicly accusing Raizada of being a criminal, committing fraud, being a racist, an anti-Semite, and preying on children. Fox, while acting in the course and scope of his authority for Defendant, communicated with, developed a scheme, and agreed to conspire with known adversaries of Raizada, Scott Asner ("Asner") and Michael Gortenburg ("Gortenburg") and their PR firm Red Banyan, to ruin Raizada financially and professionally and to attack Raizada's reputation by making additional false and defamatory statements about Raizada to other media outlets, including Newsweek, which resulted in published articles in print and on the internet falsely stating that Raizada had engaged in money laundering and other criminal or fraudulent activity. As part of Defendant's public relations campaign against Raizada, Defendant, Asner and Gortenburg engaged various marketing and search engine optimization entities to push these false narratives about Raizada into the public sphere in their relentless crusade to defame and destroy him.

4. By and through this Complaint, Raizada seeks damages resulting from Defendant's false and defamatory statements, as well as those of co-conspirators Asner and Gortenburg, all of which were published in myriad forums and on multiple websites.

THE PARTIES

5. Plaintiff Amit Raizada is an individual citizen and resident of Florida, and is

otherwise sui juris.

- 6. Defendant Echo Fox, LP is a Florida limited partnership with a registered agent located at 1200 South Pine Island Rd., Plantation, Florida 33324.
 - 7. At all times relevant, Esports was the General Partner of Echo Fox.
- 8. At all times relevant, Fox, indirectly through his holding company 1774 Ventures, LLC, was the controlling member and manager of Esports, the General Partner of Echo Fox.
- 9. Accordingly, all of Fox's actions and conduct herein were on behalf of, at the direction of, or for Echo Fox while acting in the course and scope of his authority for Echo Fox, and therefore, Defendant is liable for Fox's actions.

JURISDICTION AND VENUE

- 10. This is an action for damages in excess of \$30,000, exclusive of interest and costs, and is thus within the jurisdiction of this Court.
- 11. Jurisdiction is proper in this Court pursuant to Florida Statute § 48.193 because the Defendant is a Florida entity, who has operated and conducted business in Florida and the acts and conduct alleged herein caused harm to Raizada in Florida.
- 12. Venue is proper in Miami-Dade County, Florida, pursuant to Florida Statute § 47.051 because Plaintiff resides here, Defendant has conducted business here, and the harm occurred here.

GENERAL ALLEGATIONS

Relationship of the Parties

13. Raizada was, for several years, a business partner and affiliate of Fox, including but not limited to their ownership of and/or participation in Echo Fox, Vision Venture Partners, LLC ("VVP"), VVP Services, LLC ("VVP Services"), Twin Galaxies, LLC ("Twin Galaxies"), and several other entities.

- 14. During relevant times, Raizada was an employee of VVP Services and affiliated with Eleven Stones, LP ("Eleven Stones"), a limited partnership managed and controlled by Ravi Srivastava ("Srivastava"), Raizada's brother-in-law.
- 15. Fox and Raizada have known each other for close to two decades, and in recent years, spent a considerable amount of time together, hiking, traveling, vacationing, dining, and entertaining. Until recently, Fox and Raizada were good friends, shared celebrations together, confided in one another about family, friends, and business, and spent considerable time with one another's families.

Formation of VVP and Echo Fox

- 16. In late 2015, Fox partnered with Raizada and others to acquire the professional eSports organization Gravity Gaming, which was soon rebranded into Echo Fox. Through this purchase, Echo Fox obtained one of the coveted positions in the LCS.
- 17. At that time, Esports was formed to be the General Partner of Echo Fox. Fox and Eleven Stones collectively owned a majority of the interests of Esports. Raizada worked with an investment group to find additional investors and help implement a management team for Echo Fox. Videogame personality Jace Hall ("Hall") was named Echo Fox's CEO, and Fox agreed to serve as brand ambassador, allowing the team to use his name, likeness and sports fame to market, promote, and assist Echo Fox's growth and development.
- 18. Neither Hall nor Fox invested money into Echo Fox, and Raizada and other investors in Echo Fox relied upon Fox's promises to actively assist Echo Fox in its growth and to use his best efforts to promote Echo Fox and its brand.
- 19. In 2016, Fox, Srivastava, Hall, and former Chairman and CEO of VeriSign Inc., Stratton Sclavos ("Sclavos"), teamed up to form and operate the venture capital firm VVP, as well as a related services company, VVP Services. VVP Services employed a management team led by

Sclavos that managed Echo Fox and Twin Galaxies, and also provided consulting and other services to various companies. Raizada was employed by VVP Services and worked with Hall, Fox and Sclavos to find various investments, conduct due diligence, and promote and market opportunities to others for VVP and VVP Services.

- 20. VVP entered into a long term lease for offices in Beverly Hills, California, and subleased some of that space to Echo Fox, Twin Galaxies, and others. Fox, Sclavos, and Raizada agreed to bring all personal and non-VVP investments to VVP Services and to pay their pro rata share of overhead and other costs associated with their use of VVP's offices and the services provided. All enjoyed offices at the VVP building, and utilized administrative and support staff for their VVP and non-VVP related business activities.
- 21. Raizada and Sclavos paid millions of dollars to VVP Services for their share of office space, overhead and costs associated with their other investments. Fox did not pay any rent or overhead expenses in connection with VVP or his use of VVP Services.
- 22. Between 2016 and mid-2018, the valuation for Echo Fox increased from approximately \$10 million to more than \$53 million. During this time, Fox participated in interviews with the press, press releases, and videos that repeatedly praised Sclavos, Hall, and Raizada, described his longstanding friendship with and trust in Raizada, and attributed Echo Fox's success, in large part, to their assistance in the endeavor.

Fox obtains Control over Esports and Echo Fox

- 23. Fox's relationship with Raizada, Srivastava and Sclavos began to sour in the middle of 2018 when, due to unforeseen events, Echo Fox and Twin Galaxies experienced substantial losses. VVP Services was also experiencing financial shortfalls.
- 24. Sclavos, Raizada, and Srivastava all lent money to Echo Fox, Twin Galaxies and the VVP companies for operational and other expenses. Fox did not contribute money to VVP,

Echo Fox or Twin Galaxies.

- 25. Plaintiff and Sclavos advised Fox that he needed to start paying his share of the rent and overhead for staff he used for personal purposes at the VVP offices, or vacate the VVP offices so that they could be subleased to a paying tenant. Fox became angry and moved out of VVP's offices.
- 26. Fox blamed Sclavos, Hall, and others for Echo Fox's problems, and demanded more control over Echo Fox and its day-to-day operations. In the fall of 2018, Fox gave an ultimatum—either Fox got control over Echo Fox, or he would exit Echo Fox and stop performing his obligations as brand ambassador and the face of the company.
- 27. In order to protect Echo Fox, its investors, its fans, and Fox, Raizada brokered a deal between Srivastava (for Eleven Stones) and Fox whereby Fox would acquire a controlling interest in Esports, the General Partner of Echo Fox, from Eleven Stones and thereby gain control over Echo Fox.
- 28. On October 22, 2018, after considerable due diligence by Fox and his partner Khalid Jones ("Jones"), Eleven Stones entered into a written agreement with Fox, Axin Digital Sports Group, LLC ("Axin") (an entity in which Fox was 50% owner and manager), and others, whereby Eleven Stones sold to Axin all of its indirect member interests in Esports, giving Fox control over Esports and Echo Fox (the "SBV Holdco Transaction"). As part of the purchase price, Axin and Fox signed a promissory note ("Note") in favor of Eleven Stones in the principal amount of \$5 million, plus accrued interest due and payable on June 1, 2019. Fox personally guaranteed payment of up to \$2.5 million of the Note (the "Fox Guaranty").
- 29. On or about October 22, 2018, Eleven Stones gave its proxy to Fox (by and through 1744 Ventures, LLC and Axin), thereby vesting in him complete control over Esports, and

necessarily, Echo Fox. The SBV Holdco Transaction formally closed on January 5, 2019.

Echo Fox Conversion of Debt and Changes to the Echo Limited Partnership Agreement

- 30. In early January, 2019, Esports was attempting to raise money or obtain other sources of funds for Echo Fox and was working with an investment banker. Esports, by and through Fox and Jones, determined that Echo Fox needed to remove the millions of dollars of debt from its books rather than keep extending the due dates for those loans. Accordingly, Esports began negotiating with Echo Fox's creditors for conversion of Echo Fox debt to equity.
- 31. At that time, Raizada, by and through an indirect interest in EF Loan, LLC ("EF Loan"), held almost \$6 million in debt from Echo Fox (the "EF Debt"), which EF Loan had acquired from Twin Galaxies in December 2018 as part of a deal negotiated and agreed to by Hall in arms' length transactions as part of Hall's efforts to infuse money into Twin Galaxies. The negotiations between Raizada and Hall unfortunately resulted in a falling out between the two, as it highlighted Twin Galaxies' own financial struggles and loss of millions of dollars, which Raizada blamed on Hall's mismanagement and decisions.
- 32. On January 16, 2019, Esports, EF Loan, and most of Echo Fox's limited partners signed a Binding Term Sheet, whereby Echo Fox would create a senior preferred class of equity, the EF Debt would convert into that equity, and the Echo Fox limited partnership agreement would be amended and restated in several respects. Fox signed the Binding Term Sheet for Esports.
- 33. On January 18, 2019, Fox and Jones, for Esports, sent a letter to all limited partners of Echo Fox advising them that the Binding Term Sheet had been signed and offering to each of them the ability to acquire senior preferred equity in Echo Fox on the same terms.
- 34. On January 31, 2019, Esports and every limited partner of Echo Fox signed an Amended and Restated Limited Partnership Agreement for Echo Fox, approving amendments to, among other things, the distribution waterfall and removal of the General Partner. As part of the

transaction, Axin and 1744 Ventures (Fox's entity) released Eleven Stones, Raizada, and others from any and all claims arising out of or in connection with the SBV Holdco Transaction, and Raizada, through EF Loan, LLC, infused hundreds of thousands of additional dollars into Echo Fox.

Fox Cannot Pay His Debt and Uses Echo Fox to Harm Raizada

- 35. Within three months of taking control of Echo Fox and in light of upcoming deadlines for payment of \$5.0 million of debt owed under the SBV Holdco Transaction, Fox renewed his efforts to withdraw from Echo Fox and renege on his fiduciary duties to Echo Fox and its limited partners. Fox threatened to walk away from all responsibilities for Echo Fox.
- 36. On January 22, 2019, Raizada reminded Fox of his fiduciary duties to Echo Fox and its investors and advised Fox's attorney that if Fox breached those duties, Raizada would sue him and his family for damages incurred. Fox, while acting in the course and scope of his authority for Defendant, subsequently falsely suggested to the press that Raizada had threatened him with physical violence.
- 37. In or about February 2019, Fox, while acting in the course and scope of his authority for Defendant, began making baseless claims and threats against Raizada and Eleven Stones, falsely accusing them of fraud in relation to the SBV Holdco Transaction, as well as to the changes that were made to and approved by all partners in the Amended and Restated Echo Fox Limited Partnership Agreement. Defendant, by and through Fox, also publicly disparaged Raizada, both in correspondence sent to the limited partners of Echo Fox, and in the press.
- 38. In early April 2019, Defendant, by and through Fox, attempted to capitalize on a heated email exchange between Raizada and Hall in which Raizada uttered a racial slur toward Hall. Raizada apologized to Hall for the inappropriate comment. Even though that exchange did not involve Fox or Echo Fox in any respect, Fox immediately sent Raizada's email to every

investor of Echo Fox; threatened Raizada with a series of legal claims; attempted to extort debt forgiveness from Eleven Stones; and used the email to deflect from Defendant's breach of Echo Fox's obligations to Riot Games in respect of the LCS.

- 39. On or about April 25, 2019, Defendant, by and through Fox, leaked Raizada's email to Hall to the media, thereby starting a media frenzy against Raizada. Over the course of the next several weeks, Defendant, through Fox, made several statements to and participated in interviews with the press falsely defaming Raizada by accusing him of being a racist, of threatening physical violence, and of engaging in fraudulent and/or criminal conduct. A spreadsheet showing the publishers who published such false and defamatory statements about Raizada and the dates of such publication is attached as Exhibit A.
- 40. On or about April 26, 2019 and based on the above, Defendant, by and through Fox, reached out to Riot Games, the owner of the LCS, and demanded that they force Echo Fox to remove Raizada from his indirect ownership position with Echo Fox. That demand caused Riot Games to investigate Echo Fox's finances and business practices, revealing that Echo Fox had materially breached its agreement with Riot in at least three ways: (1) Defendant and Esports failed to maintain liquidity in Echo Fox of \$5 million; (2) Defendant and Esports failed to obtain Riot's approval for a loan to Echo Fox in excess of \$1 million; and (3) Defendant and Esports failed to obtain Riot's prior approval for the EF Loan conversion transaction on January 31, 2019. Based on these breaches, Riot required Echo Fox to sell its LCS slot.
- 41. On July 30, 2019, Fox, while acting in the course and scope of his authority for Defendant, participated in a one-hour interview with Dexerto.com's Richard Lewis, wherein Defendant made several false and defamatory statements about Raizada and his role in causing a forced sale of Echo Fox's LCS slot. Defendant falsely painted Raizada as the villain and catalyst

of Echo Fox's demise and made defamatory statements about Raizada, stating, among other things:

- (a) Investors did not want to work with Echo Fox due to Raizada's indirect involvement: "[Y]ou had investors wondering why would they want to pay an antisemitic, racist, self-dealing, fraudulent individual? . . . Why would they line his pockets with their money?";
- (b) Rather than extend the EF Debt, Raizada purchased the debt secretly and "put a gun to the company's head";
- (c) Raizada, as an existing shareholder in Echo Fox, purchased the debt from Twin Galaxies and then immediately threatened to call the debt, which put the company in a tailspin and was a breach of contract;
 - (d) Raizada leaked the email with the racial slur to the press;
- (e) All of Echo Fox's problems go back to Raizada--his behavior put a negative value on Echo Fox and caused Riot Games to auction off the LCS slot;
- (f) Raizada's comments and business practices damaged Echo Fox and its ability to raise money;
- (g) Raizada changed the Echo Fox partnership agreement on the day of signing to move certain investors down in priority in the capital table to a lower position than they were before;
- (h) All of the limited partners of Echo Fox were okay with the Dick Clark offer to purchase Echo Fox's LCS slot; they just couldn't get to the right valuation because of the way Raizada had changed the waterfall;
 - (i) Raizada sent misinformation to Echo Fox investors;
- (j) "If the money flows through agreements Raizada constructed, a lot of people lose";

- (k) Raizada changed the Echo Fox partnership agreement in a fraudulent fashion:
 - (l) Fox bought Echo Fox to get control because Raizada was self-dealing;
- (m) Raizada devalued Echo Fox and prevented a raise in value by his behavior and structure and fraud he created and by his breach of contract;
 - (n) Raizada is a racist and has a history of self-dealing; and
 - (o) Echo Fox failed because no one wanted to be in business with Raizada.
- 42. Following the Dexerto interview, several other publishers published additional defamatory statements and/or republished the false statements made by Fox, while acting in the course and scope of his authority for Defendant, in the Dexerto interview, including;
- (a) Dotesports, which quoted Fox as saying: Raizada "damaged the company, eroded the value, prevented a raise [in value] by structure he created, and he breached the contract. Not only did Raizada's comments and his business practices damage the company, it actually also damaged Echo Fox's ability to raise capital and operate a healthy company";
- (b) Dexerto, which published an article confirming Fox stated that Raizada changed the working agreement that he had with Echo Fox and structure it so he would benefit most all without telling anyone. This could be considered fraud;
- (c) Forbes posted an article stating, according to Fox, Raizada changed the Echo Fox agreement and "Rick Fox claims that because Raizada was at the top of Echo Fox, any investors doing their due diligence realized it would not be a sound investment, and further investment could not be secured";
- (d) Kotaku quoted Fox as stating Raizada was a "bully", engaged in "self-dealing" and "was holding the company hostage"; and

- (e) Upcomer posted an article stating that according to Fox, Raizada had gone behind the back of Echo Fox's shareholders and changed the operating agreement to raise his influence and lower that of other shareholders.
- 43. Numerous other newscasters, bloggers and sports reports also republished Fox's disparaging comments about Raizada.
- 44. On or about August 1, 2019, Kyle Fox, Fox's son, tweeted a screenshot of an online public records search that inaccurately suggested that Raizada had a criminal history which included unlawful sexual conduct with a minor in the state of Ohio. Kyle Fox commented that, "From my interactions with Amit Raizada I was always suspicious. It took more digging tha[n] it should to find this. This is the man who's attacking my father @RickFox right now." Within an hour, Fox, while acting in the course and scope of his authority for Defendant, retweeted his son's screenshot and added, "Racisim is one thing but preying on children is something else entirely I'm horrified I didn't know this sooner There are women in my life who have suffered from crimes like this I am angry beyond belief."
- A5. Raizada defended himself via twitter, explaining that the case Fox had circulated had been dismissed on December 11, 2013 as a case of mistaken identity. Raizada had not even been in Ohio in October 1996, the date of the alleged incident. Raizada, through his attorneys, notified both Kyle and Rick Fox via letter that the information they had posted was inaccurate. While both Kyle and Rick Fox eventually removed their tweets, Kyle Fox replaced his misleading post with a new one, attaching the letter Raizada's attorneys had sent him. And, despite being provided proof of Raizada's innocence, on August 5, 2019, Rick Fox, while acting in the course and scope of his authority for Defendant, tweeted the following: "Attention Media: Some of you are still listening to an admitted racist and liar who carries a criminal record and you expect me to

further respond to what he says?"

- 46. Publishers, including esports observer, subsequently published articles stating that "in addition to multiple lawsuits and an assault charge, [Fox] has since learned that Raizada was charged for unlawful sexual misconduct with a minor in 1997, to which Raizada claims was a case of 'mistaken identity.'"
- 47. In each of these statements, Fox was acting in his capacity as the controlling member and manager of the General Partner of Echo Fox in the ordinary course of Echo Fox's business. Thus, all of these defamatory statements were made by or are attributable to the Defendant.

Defendant Conspires With Raizada Adversaries to Harm Raizada

- 48. During this time period, Defendant, by and through Fox, conspired with known adversaries of Raizada, to wit: Asner and Gortenburg; to further defame and harm Raizada.
- 49. Defendant reached an understanding and meeting of the minds with Asner and Gortenburg to work together to publish false and defamatory statements about Raizada and to publish private matters related to Raizada. By doing so, Defendant, along with Asner and Gortenburg, intended to harm Raizada's reputational and pecuniary interests.
- 50. Upon information and belief, Asner and Gortenburg had agreed to assist Defendant and/or Fox in connection with litigation that might arise with Raizada, including an agreement to fund such efforts.
- 51. In or about May 2019, Daniel Blegen, counsel for Asner and Gortenburg in a case brought by them and others against Raizada in Missouri, met with Fox and other representatives of Defendant at Defendant's offices, where Fox, for Asner and Gortenburg, solicited information in an effort to help Asner and Gortenburg in their litigation against Raizada. Blegen also appeared in the background of a live interview Fox, while acting in the course and scope of his authority for

Defendant, was giving to TMZ about Raizada.

- 52. Around that same time, Red Banyan, a PR firm paid by Asner and Gortenburg, contacted Steven Asarch ("Asarch") of Newsweek, an esports reporter who was good friends with Fox and had written a biased article in connection with the disputes that had arisen between Raizada and Fox. Red Banyan provided Asarch with private information about Raizada and suggested Asarch should interview Gortenburg for additional statements to help Defendant and Fox.
- 53. Shortly thereafter, Gortenburg participated in an interview with Asarch of Newsweek for an article involving Defendant in which Gortenburg made several false and defamatory statements about Raizada, including but not limited to:
- (a) Gortenburg is currently on his fourth lawsuit against Raizada, claiming that he had "stolen over a million dollars" from him personally;
 - (b) [Raizada's] always been a bit of a fractured person;
 - (c) [Raizada] always spins things and lies for his betterment...; and
- (d) Gortenburg claims that Raizada had been taking money from the company to use for his own personal benefit, including among other accusations, money laundering.

 Those false statements were published by Newsweek on or about May 24, 2019.
- 54. Within a few weeks of that Newsweek article, Fox posted Instagram pictures of himself and Asner with captions about having friends you can trust.
- 55. In October 2019, after months of trying to help Asner and Gortenburg harm Raizada, Fox subsequently admitted in sworn testimony that he has no personal knowledge of any of the disputes presently being litigated between Raizada and Asner and Gortenburg.

COUNT I:

(DEFAMATION PER SE)

- 56. Plaintiff re-alleges and incorporates paragraphs 1 through 55 above as if fully set forth herein.
- 57. Between April 25, 2019 and August 31, 2019, Fox, while acting in the course and scope of his authority for Defendant, made and/or published the false and defamatory statements of and concerning Raizada set forth above or conspired with others to make defamatory statements, including: (1) Raizada is a "self-dealing, fraudulent individual"; (2) Raizada engaged in "fraudulent activity"; (3) Raizada is a "racist" and "anti-Semite"; (4) Raizada "prey[ed] on children"; (5) Raizada "carries a criminal record"; (6) Raizada had previously been convicted of fraud in a court of law; and (7) Raizada had been accused of money laundering.
- 58. Defendant's false accusations of fraud, dishonesty, and criminal behavior are defamatory per se as they (a) charge that a person has committed an infamous crime; (b) tend to subject Raizada to hatred, distrust, ridicule, contempt, or disgrace; or (c) tend to injure Raizada in his trade or profession.
- 59. These false statements were understood by those who read them in a way that defamed the reputation of Raizada and his business, in that the allegations ascribe to Raizada efforts to cheat, defraud, and otherwise take advantage of his business partners or investors in the businesses he operates or manages. Further, the statements also imply that Raizada was charged with having committed unlawful sexual conduct with a minor. Any ordinary reader would understand that engaging in fraud and acts of child predation are despicable acts that are both morally and legally reprehensible.
- 60. These statements were published by Defendant with malice. Defendant failed to use reasonable care to determine the truth or falsity of the statements, and indeed knew that they

were false when Fox made them.

61. As a proximate result of the above-described false publications, Raizada suffered

reputational damages in a total amount to be proven at trial.

62. As a proximate result of the above-described false publications, Raizada has also

suffered monetary losses, in a total amount to be proven at trial.

63. Because of Defendant's oppression, fraud and malice in publishing the foregoing

false statements, Raizada reserves the right to amend this Complaint to seek punitive damages as

allowed by Florida Law.

WHEREFORE, Plaintiff Amit Raizada seeks judgment against Defendant Echo Fox, LP,

for compensatory damages in an amount to be proven at trial, for prejudgment and post-judgment

interest at the maximum legal rate, , for costs of suit and reasonable attorneys' fees allowable by
