UPON RETURNING ON JULY 18, 2025, AT APPROXIMATELY 2100 HOURS, THE VICTIM DISCOVERED HIS ROLEX WATCH MISSING FROM THE RESIDENCE. NO SIGNS OF FORCED ENTRY WERE REPORTED, AND THE VICTIM SUSPECTED SOMEONE WITH ACCESS TO THE KEY HAD UNLAWFULLY ENTERED THE APARTMENT AND STOLEN THE WATCH. ON AUGUST 28, 2025, THE VICTIM CONTACTED THE BURGLARY OFFICE ADVISING THAT THE MIAMI DADE SHERIFFS OFFICE TOLD HIM THAT HIS WATCH WAS PAWNED. THIS DETECTIVE CONDUCTED A PROPERTY SEARCH USING THE STOLEN ROLEXS SERIAL NUMBER THROUGH THE LEADS ONLINE DATABASE. THE SEARCH REVEALED A POSITIVE MATCH: THE ROLEX HAD BEEN PAWNED ON AUGUST 8, 2025, AT APPROXIMATELY 1130 HOURS BY THE DEFENDANT. DURING THE PAWN TRANSACTION, THE DEFENDANT PRESENTED A VALID ) AND PROVIDED A CONTACT TELEPHONE NUMBER. THE TRANSACTION WAS DOCUMENTED UNDER PAWN FLORIDA ID ( TICKET# ON AUGUST 28TH, 2025 THE VICTIM SUPPLIED SCREENSHOT EVIDENCE OF TEXT MESSAGES IN WHICH THE DEFENDANT SENT TO 1/4/2 (WITNESS 1) AND ADMITTED TO THE THEFT. IN ONE MESSAGE, THE DEFENDANT STATED: .. " THIS "IT WAS A DIFFERENT VERSION OF ME THAT TOOK THE WATCH AND A DIFFERENT VERSION OF ME THAT STOLE FROM MESSAGE CONSTITUTES A PARTIAL CONFESSION AND CORROBORATES THE VICTIMS ACCOUNT OF THE INCIDENT. ON AUGUST 28, 2025, THE DEFENDANT VOLUNTARILY ARRIVED AT THE MIAMI POLICE HEADQUARTERS AND TURNED HIMSELF IN. UPON INITIAL CONTACT, THE DEFENDANT IMMEDIATELY INVOKED HIS RIGHT TO LEGAL COUNSEL. NO FURTHER QUESTIONING WAS CONDUCTED. THE VICTIM WAS PRESENTED A SINGLE PHOTO OF THE DEFENDANT WHERE HE POSITIVELY IDENTIFIED HIM. DEFENDANT ARRESTED. SAO PRE-FILE CONFERENCE...
