SUBJECT WAS OBSERVED WALKING WESTBOUND ON THE CROSSWALK AT 14TH ST AND COLLINS AVE. THE SUBJECT THEN ENTERED THE WALGREENS LOCATED AT 1400 COLLINS AVE.

AT APPROXIMATELY 1313 HRS, OFC. SABATER DETAINED THE SUBJECT INSIDE OF THE WALGREENS. LT. VILLAR, OFFICER CAMPOS (2054) AND OFFICER CRUZ (2254) THEN RESPONDED TO ASSIST. OFFICER CRUZ AND OFFICER CAMPOS THEN TRANSPORTED MR. MONTECINO TO THE CRIMINAL INVESTIGATIONS DIVISION, WHERE HE WAS INTERVIEWED BY MIAMI BEACH DETECTIVE PORRO 1055 AND SECRET SERVICE AGENTS. A RECORDS CHECK OF CALIFORNIA ID (F1924314,) REVEALED THE NAME (TORRES CARMEN LUCIA & DOB 01/26/1986.)

POST MIRANDA PER FORM, THE DEFENDANT (MR MONTECINO) ADMITTED TO DET. PORRO (1055) OF BEING IN POSSESSION OF THE FICTITIOUS CALIFORNIA IDENTIFICATION CARD AND PROVIDING IT TO THE OFFICERS. THE DEFENDANT STATED THAT HE INITIALLY PURCHASED THE CALIFORNIA IDENTIFICATION CARD FOR WORK PURPOSES. THE EVIDENCE WAS IMPOUNDED INTO THE PROPERTY EVIDENCE UNIT AT MBPD AS INVESTIGATORY EVIDENCE. THE DEFENDANT WAS CHARGED ACCORDINGLY.

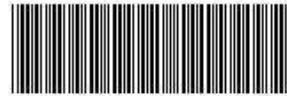
