






THIS IS THE AREA DESIGNATED FOR THE CHAMPLAIN MEMORIAL

The entire 88th Street from Collins to the Beach



SURFSIDE MAYOR AND COMMISIONERS, WE RESPECTFULLY ASK YOU THAT...


