Upon arrival I met with (victim) [REDACTED] (16 yoa) and her Father [REDACTED] who advised on 8/15/20 she was volunteering for the Jen Perelman for Congress Campaign team at 16835 Sheridan St (SW Regional Library) and her primary job was to hand out flyers.


[REDACTED] stated on 4 separate occasions between 1pm-2pm during the event, the Candidate Debbie Wasserman Schultz (suspect) would make physical contact with her by shoving with the side of her arm to prevent [REDACTED] from handing out flyers to people. [REDACTED] stated the shoving would happen multiple times so Schultz could hand out her political flyers. [REDACTED] believes these acts were done by Schultz to antagonize her.

[REDACTED] requested that an information report be documented by Police for this incident.
