ON THE FRONT WAS SPRAYED " DIKE BITCH, SHUT THE F UP, AND LOVE SANTA". LEFT SIDE "IGNORANT NIGGERS" WITH A SPRAYED PEACE SIGN. RIGHT SIDE "DONT PUT YOUR BIZ IN DA STREET" AND "YOU NEED THERAPY".
