HE WAS MONITORING THE KIDS IN THE POOL REFERENCE AN END OF SUMMER POOL EVENT.

HE WAS OBSERVED IN DISTRESS AND AFTER A WHILE SEVERAL COACHES AND LIFEGUARDS TOOK HIM OUT THE POOL.

LIFEGUARDS WERE ADMITTING CPR UNTIL MIAMI BEACH FIRE RESCUE ARRIVED.

MIAMI BEACH FIRE RESCUE#2 TRANSPORTED THE PATIENT PERNIEL JANVIER TO MOUNT SINAI HOSPITAL FOR FURTHER MEDICAL ATTENTION.

SGT. A. TORRES WAS ON SCENE AND GATHERED SEVERAL INFORMATION FROM THE STAFF.

STAFF INFORMATION IS LISTED IN THE SUBJECT'S SECTION.

LT. PAYNE, SGT DET. A. GONZALEZ, SGT. M. MULEY AND SGT. BOLDUC WERE ADVISED OF THE INCIDENT.

OFFICER S. VELEZ RESPONDED TO MT. SINAI HOSPITAL AND WAS ADVISED BY DR. DEVARONA THAT MR. JANVIER WAS IN CRITICAL CONDITION, HAS A PULSE AND BREATHING THROUGH ASSISTANCE OF VENTILATION MACHINE. UNKNOWN IF HE HAS ANY BRAIN ACTIVITY UNTIL THEY PERFORM A CAT SCAN.

UNTIL NOW THERE IS NOW SIGNS OF FOUL PLAY.

MT. SINAI HOSPITAL WILL ADVISE OF ANY FURTHER MEDICAL CONCERNS TO MIAMI BEACH POLICE.
