SANCHEZ POINTED ME IN THE DIRECTION WHERE THE DEFENDANT LEWIN, ROBERT CASH WAS SITTING INSIDE A BLACK LINCOLN NAVIGATOR BEARING TAG# 411PAIN LOCATED ON THE SCHOOL GROUNDS PARKING LOT. DEPUTY RAFAEL (ID 10554) AND DEPUTY SAINTIL (ID 10559) THEN MADE CONTACT WITH DEFENDANT LEWIN, ROBERT. THE DEFENDANT WAS ADVISED TO STEP OUT OF THE VEHICLE AND A PAT DOWN WAS CONDUCTED REVEALING A FIREARM WAS FOUND ON HIS RIGHT SIDE WAIST BAND WITH A EXTRA MAGAZINE AND A KNIFE.
