OfficerID: cmb\POLIVelE, Narrative

ON THE LISTED DATE AND TIME, OFFICERS BLANDON (2085), LAGOS (2100), GONZALEZ (2266), SANCHEZ (2276), AND I RESPONDED TO 1624 WASHINGTON AVE (TACO BELL) IN REFERENCE TO A BATTERY.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE VICTIM, IDENTIFIED AS YULISSA ESCOBAR, AND HER FRIEND. MS. ESCOBAR STATED THAT WHILE SHE WAS WAITING FOR HER FOOD INSIDE TACO BELL, AN UNKNOWN COUPLE ENTERED THE RESTAURANT. MS. ESCOBAR STATED THAT THE MALE OF THE UNKNOWN PAIR BEGAN MAKING INAPPROPRIATE REMARKS TOWARD HER, STATING, "YOU LOOK GOOD." MS. ESCOBAR STATED SHE IGNORED THE COMMENTS AND CONTINUED WAITING FOR HER FOOD.

MS. ESCOBAR THEN STATED THAT THE FEMALE ACCOMPANYING THE MALE APPROACHED HER AND STRUCK HER ON THE RIGHT CHEEK. MS. ESCOBAR WAS UNABLE TO RECALL IF SHE WAS STRUCK WITH AN OPEN OR CLOSED HAND. OFFICERS OBSERVED SLIGHT BLEEDING ON MS. ESCOBAR'S RIGHT EAR.

MS. ESCOBAR FURTHER STATED THAT THE COUPLE LEFT IN A WHITE MERCEDES BENZ, FLEEING SOUTHBOUND ON WASHINGTON AVENUE.

THE STORE MANAGER WAS UNABLE TO ACCESS THE CCTV FOOTAGE AT THE TIME OF THE INCIDENT BUT STATED IT WOULD BE AVAILABLE AT A LATER TIME. AN AXON LINK WAS PROVIDED TO THE MANAGER, IDENTIFIED AS ELIZABETH GUITART, TO UPLOAD ANY AVAILABLE CCTV FOOTAGE.

CRIME SCENE TECHNICIAN REVILLA (1005) RESPONDED TO PHOTOGRAPH THE VICTIM.

MS. ESCOBAR REFUSED FIRE RESCUE.

A CASE CARD AND A VICTIMS RIGHTS PAMPHLET WERE ISSUED TO MS. ESCOBAR.

BODY WORN CAMERA WAS UTILIZED.
