Before me this date personally appeared AVONA, MICHAEL J. (19821) who being first duly sworn deposes and says that on 13 day of January, (year) 2026 at 920 NW 8TH AV, POMPAÑO BEACH, FL 33060 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On Tuesday, January 13th, 2026, while actively working a shooting investigation which had just occurred involving a gray BMW the defendant later identified as Jeremyah Taylor began to rapidly approach me shouting unknown statements, not knowing the defendants intentions I pointed my firearm towards him and advised him to stop multiple times to which he disregarded, I then advised him to get on the ground and again he ignored my commands. At this point, I reached for his sweatshirt to pull him away from the BMW and

Probable Cause Affidavit

Before me this date personally appeared AVONA, MICHAEL J. (19821) who being first duly sworn deposes and says that on 13 day of January, (year) 2026 at 920 NW 8TH AV, POMPAÑO BEACH, FL 33060 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

preserve the crime scene. It should be noted that the area to the rear of the BMW, where the defendant was walking, had fresh blood. The defendant immediately swatted my hand away, making contact with my hand. At this point, I advised my partner, Trainee Deputy Gordon, to place the defendant into custody. I then ordered the defendant to put his hands behind his back. As I grabbed hold of him, he began to resist me actively and Deputy Gordon by tensing, bracing his shoulders, and pulling away from us, preventing us from placing him into handcuffs. I instructed the defendant to put his hands behind his back which he refused to do, I then picked up the subject's legs to defeat his balance, as the subject was brought to the ground, he grabbed hold of Deputy Gordons foot causing Deputy Gordon to lose his balance and fall to the ground the defendant continued to resist refusing repeated requests to stop resisting and place his hands behind his back. Eventually, we were able to secure the defendant and put him into custody.

The defendant is being charged with 2 counts of Battery on a Law Enforcement Officer and resisting without violence.

The subject was then transported to the BSO Main Jail.
