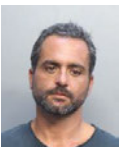

ON 05/11/2026 AT APPROXIMATELY 1859 HOURS, OFFCIERS WERE DISPATCHED TO 1988 WEST AVE IN REFERENCE TO A MALE TRESPASSING. (LATER IDENTIFIED AS DEFENDANT JOSHUA KOREN).

UPON ARRIVAL OFFICER MARTI #2215 AND OFFICER ANDERSON #785 WERE FLAGGED DOWN BY WITNESS REDPATH. WITNESS REDPATH POINTED AT A BLUE PORSCHE 911 CARRERA BEARING FL TAG [REDACTED] WHICH WAS IN THE DRIVEWAY OF THE RESIDENTAL BUILDING. WITNESS REDPATH STATED THAT THE DRIVER OF THE VEHICLE (DEFENDANT KOREN) WAS "THE GUY STALKING THE VICTIM". WITNESS REDPATH FURTHER STATED THAT THE DEFENDANT WAS GIVEN A TRESPASS WARNING ON 05/07/2026 AFTER HE ARRIVED AT THE LOCATION AND CAUSED A SCENE (MIAMI BEACH POLICE CASE #2026-37186). OFFICERS MARTI AND ANDERSON THEN MADE CONTACT WITH THE DEFENDANT WHO STATED HE WAS VISITING HIS GIRLFRIEND [REDACTED] WHO LIVED IN THE BUILDING. DEFENDANT KOREN ALSO STATED THAT HE WAS MOVING INTO THE APARTMENT WITH THE VICTIM AND HAD PURCHASED HER SOME GROCERIES. DEFENDANT KOREN THEN MOVED HIS VEHICLE TO THE STREET WHERE HE BLOCKED A FIRE HYDRANT.

OFFICER MARTI AND OFFICER ANDERSON SPOKE WITH THE VICTIM WHO STATED SHE HAD NOT INVITED THE DEFENDANT TO HER APARTMENT AND THAT HE HAD NO REASON TO BE THERE.

WHILE OFFICER MARTI AND OFFICER ANDERSON WERE SPEAKING WITH THE VICTIM, WITNESS [REDACTED] STATED THAT SHE IS THE VICTIM'S NEIGHBOR AND THAT SHE WAS HAVING A SECURITY SYSTEM INSTALLED ON HER APARTMENT DUE TO THE BEHAVIOR OF THE DEFENDANT ON 05/07/2026. WITNESS [REDACTED] STATED THE DEFENDANT CAUSED A SCENE AND WAS BANGING ON HER DOOR. THE WITNESS FURTHER STATED PRIOR TO POLICE ARRIVAL THE DEFENDANT HAD BEEN BANGING ON HER DOOR THINKING THAT THE VICTIM RESIDED IN HER RESIDENCE. SHE ALSO STATED THE DEFENDANT WAS ACTIVELY ATTEMPTING TO GAIN ACCESS TO THE APARTMENT BY TWISTING THE DOORKNOB AND CALLING OUT FOR THE VICTIM.

SECURITY GUARD SENECHARLES STATED THAT THE DEFENDANT GAINED ACCESS TO THE RESTRICTED BUILDING BY FOLLOWING OTHER UNINVOLVED PARTIES INTO THE BUILDING.

DEFENDANT KOREN ARGUED WITH OFFICERS ON SCENE AND STATED HE HAD EVERY RIGHT TO BE AT THE LOCATION BECAUSE HIS GIRLFRIEND RESIDED THERE. DEFENDANT KOREN WAS TAKEN INTO CUSTODY AND TRANSPORTED TO MIAMI BEACH POLICE DEPARTMENT.

OFFICER MARTI AND OFFICER ANDERSON THEN TOWED DEFENDANT KOREN ILLEGAL PARKED VEHICLE AND WHILE CONDUCTING INVENTORY OF THE VEHICLE OFFICER ANDERSON LOCATED A BAG WHICH CONTAINED TWO NEW... [Continued on Next Page]

DRESSES, TWO FOLDING KNIVES, A CAN OF PEPPER SPRAY AND A JABRE STUN GUN. DEFENDANT KOREN SPONTANEOUSLY STATED THAT THE ITEMS WERE "GIFTS" FOR THE VICTIM. ALL ITEMS WERE IMPOUNDED. DETECTIVE CORVO CONTACTED THE VICTIM WHO RESPONDED TO MIAMI BEACH POLICE DEPARTMENT TO PROVIDE A SWORN STATEMENT.
