THE BAD ACTORS THEN CAN USE THE VICTIMS INFORMATION TO LOG INTO THEIR BANK ACCOUNTS ELECTRONICALLY AND VIA THE BANKING APPS OR WEBSITES. THE VICTIMS FUNDS ARE THEN DEPLETED OR TAKEN OVER.

ON JULY 6, 2026, VIA ELECTRONIC MEANS, YOUR AFFIANT AND FBI AGENT G. MENOCAL OBSERVED THE DEFENDANT LIVE STREAM HIMSELF IN REAL TIME AT THE PREMISES. DURING THE LIVE VIDEO, THE DEFENDANT WAS RAPPING IN SPANISH AND DISPLAYS A GLOCK STYLE FIREARM WITH AN EXTENDED MAGAZINE, LARGE AMOUNTS OF US CURRENCY, AND A LAPTOP. THE DEFENDANT FLIPS THE CAMERA AND DISPLAYS THE LAPTOP SCREEN SHOWING MULTIPLE VICTIMS PERSONAL IDENTIFIABLE INFORMATION (P.I.I.). THE DEFENDANT DESCRIBES HOW HE COMMITS ORGANIZED FRAUD AND SPOOFING SCHEMES. THE DEFENDANT FLASHES A BOTTLE OF SUSPECTED PROMETHAZINE WHILE HES WALKING AROUND THE KITCHEN OF THE PREMISES. THE DEFENDANTS ITS PURPLES DRANK NOT THAT BULLSHIT YALL BE DRINKING WHICH IS WHY YALL DONT GET HIGH AS HE FLASHED THE BOTTLE OF SUSPECTED PROMETHAZINE.

ON JULY 20, 2026, YOUR AFFIANT OBSERVED THE DEFENDANT ENTERING AND EXITING THE PREMISES. THE DEFENDANT HAS ALSO PREVIOUSLY POSTED PICTURES NEAR THE PREMISES. THE DEFENDANT ALSO HAS THE PREMISES LISTED AS ONE OF HIS MAILING ADDRESSES.

ON JULY 21, 2026, VIA ELECTRONICAL MEANS, YOUR AFFIANT OBSERVED THE DEFENDANT IN A BATHROOM AND FLASHING MULTIPLE DEBIT/CREDIT/GIFT CARDS WHILE CONCEALING A SUSPECTED FIREARM THAT HAS AN EXTENDED MAGAZINE AND GRABS THE EXTENDED MAGAZINE OF THE FIREARM. IN THE VIDEO, THERE IS ALSO A WAD OF U.S. CURRENCY ON THE SINK/COUNTER.

ON JULY 22, 2026, THE HONORABLE JUDGE A. WOLFSON SIGNED AND AUTHORIZED A RESIDENTIAL SEARCH WARRANT REGARDING THE PREMISES.

ON JULY 23, 2026, THE MIAMI DADE SHERIFF'S OFFICE (MDSO) SRT, CITY OF MIAMI SPECIAL INVESTIGATION SECTION (SIS), FBI VIOLENT GANG TASK FORCE, EXECUTED THE RESIDENTIAL WARRANT AT THE PREMISES. THE DEFENDANT AND HIS SISTER WERE REMOVED FROM THE KITCHEN NEXT TO LESTERIOS ROOM.

IN THE REAR OF THE PREMISES, LAW ENFORCEMENT DISCOVERED 2 DEAD CHICKENS WITH THEIR HEADS CUT OFF. INSIDE THE ROOM NEXT TO THE DEAD CHICKENS, WAS A ROOM FULL OF CUBAN SANTERIA/VOODOO WITCH CRAFT. LAW ENFORCEMENT THEN DISCOVERED A LIVE BABY GOAT INSIDE A BOX NEAR THE SANTERIA WITCH CRAFT MATERIAL. THE BABY GOATS NECK WAS PAINTED IN ORANGE WHICH IS A SIGN MARKING WHERE THE ANIMAL WOULD GET CUT/SLAUGHTERED. AFTER VIGIROUSLY SEARCHING FOR RELOCATION, MDSO DISPACTHERS WERE ABLE TO LOCATE PLACEMENT FOR THE BABY GOAT VIA MIAMI ANIMAL RESCUE. IN EFFORTS OF PRESERVING THE LIFE OF THE BABY GOAT, DETECTIVE R. ROJAS 001-45300 TRANSPORTED THE BABY GOAT TO THE VARELA HIGH SCHOOL FARM UNTIL ITS PERMANENT RE-LOCATION WITH MIAMI ANIMAL RESCUE (UNDISCLOSED DUE TO THE SAFETY OF THE GOAT). SUBSEQUENTLY, FBI AGENTS DISCOVERED A VIDEO OF THE DEFENDANT HOLDING TWO DEAD CHICKENS DANGLING BY THEIR FEET IN HIS HAND WHICH ARE CONSISTENT WITH THE DEAD CHICKENS LOCATED IN THE REAR OF THE PREMISES.

THE DEFENDANT WAS TRANSPORTED TO THE CITY OF MIAMI SIS OFFICE. YOUR AFFIANT AND FBI AGENT MENOCAL READ HIS CONSTITUTIONAL RIGHTS PER FORM TO WHICH HE SIGNED AND AGREED TO SPEAK TO LAW ENFORCEMENT. THE DEFENDANT STATED HES LIVED AT THE PREMISES FOR A YEAR AND A HALF AND THE ROOM WHERE ALL CONTRABAND WAS RECOVERED BELONGS TO HIM. THE DEFENDANT STATED HE PURCHASED THE FIREARM AT A BASS PRO SHOP AND PURCHASED THE BOTTLE OF PROMETHAZINE ONLINE TO CURE HIS SICKNESS. THE DEFENDANT ALSO STATED HE PREVIOUSLY ATTEMPTED TO COMMIT FRAUD. THE DEFENDANT THEN INVOKED HIS RIGHT TO NOT SPEAK TO LAW ENFORCEMENT. THE DEFENDANT WAS ARRESTED AND TRANSPORTED TO TGK.
