THE RESIDENCE BELONGED TO TWO VICTIMS, A MARRIED COUPLE, WHO DEPARTED ON VACATION ON AUGUST 12, 2026. DURING THEIR ABSENCE, THE VICTIMS HAD ARRANGED FOR THEIR HOUSEKEEPER, MS. MARIA PEREZ, RESPOND DAILY TO AND MAINTAIN THE RESIDENCE. ON AUGUST 19, 2026, BOTH VICTIMS WERE TRAGICALLY KILLED IN AN UNFORESEEN FATAL ACCIDENT WHILE AWAY FROM THE RESIDENCE. THE HOUSEKEEPER WAS NOTIFIED OF THEIR DEATHS THAT SAME DAY. SUBSEQUENT INVESTIGATION ESTABLISHED THAT THE RESIDENCE AND THE VICTIMS PROPERTY REMAINED INTACT FOLLOWING THE ACCIDENT. AT SOME POINT BETWEEN APPROXIMATELY 1653 HOURS ON AUGUST 20, 2026, AND AUGUST 22, 2026, UNKNOWN OFFENDERS UNLAWFULLY ENTERED THE RESIDENCE. ONCE INSIDE, THE OFFENDERS RANSACKED THE RESIDENCE AND REMOVED NUMEROUS ITEMS BELONGING TO THE DECEDENT SUCH AS PERSONAL AND BUSINESS DOCUMENTS, JEWELRY, ELECTRONICS, AND ARTWORK. THE OFFENDERS ALSO REMOVED TWO MOTOR VEHICLES BELONGING TO THE DECEDENTS FROM THE RESIDENCE. THE VEHICLES ARE DESCRIBED AS FOLLOWS: 1. 2023 LAND ROVER RANGE ROVER, VIN: SALKP9E7PA056569, FL TAG: P4RRA. 2. 2020 PORSCHE TAYCAN, VIN: WPOAC2412LSA71779, FL TAG: ICUP10. ON AUGUST 23, 2026, THE DECEDENTS HOUSEKEEPER RETURNED TO THE RESIDENCE AND DISCOVERED THAT AN UNAUTHORIZED PERSON OR PERSONS HAD ENTERED THE RESIDENCE, RANSACKED THE INTERIOR, REMOVED PROPERTY, AND STOLEN THE ABOVE-DESCRIBED VEHICLES. FURTHER INVESTIGATION REVEALED THAT THE DECEDENTS APPLE MACBOOK PRO BEARING SERIAL NUMBER L7LMQ2TDWR THAT WAS STOLEN IN THE BURGLARY. THE FIND MY APPLICATION WAS UTILIZED AND SHOWED THAT THE STOLEN MACBOOK WAS ACTIVELY REPORTING ITS LOCATION AT OR IN THE IMMEDIATE VICINITY OF 8396 NW 195TH TERRACE HIALEAH FL 33015. THE MACBOOK CONTINUED TO ELECTRONICALLY REPORT/PING AT THE ABOVE LOCATION THROUGHOUT THE EVENING OF AUGUST 23, 2026. PHOTOGRAPHS/SCREENSHOTS DEPICTING THE LOCATION INFORMATION OBTAINED THROUGH THE FIND MY APPLICATION WERE SHARED BY THE VICTIMS BUSINESS PARTNER/ASSOCIATE, MS. HOPE DIAZ AND THE VICTIMS EXECUTOR OF ESTATE, MS. RENEE HLAVATY. ON AUGUST 24, 2026, I WAS CONTACTED BY THE VICTIMS BUSINESS PARTNER/ASSOCIATE, MS. HOPE DIAZ. SHE PROVIDED ME WITH AN ADDITIONAL PHOTOGRAPH/SCREENSHOT FROM THE APPLE FIND MY APPLICATION DEPICTING THE ELECTRONIC LOCATION ASSOCIATED WITH A SPARE KEY BELONGING TO THE DECEDENTS STOLEN LAND ROVER RANGE... ROVER. THE RANGE ROVER SPARE KEY WAS ELECTRONICALLY LOCATED AT THE SAME LOCATION, OR WITHIN THE SAME IMMEDIATE AREA, WHERE THE DECEDENTS STOLEN APPLE MACBOOK HAD BEEN ACTIVELY REPORTING ITS LOCATION. THE LOCATION INFORMATION ASSOCIATED WITH THE RANGE ROVER SPARE KEY REFLECTED A LAST REPORTED LOCATION ON AUGUST 22, 2026, AT APPROXIMATELY 2338 HOURS, AT OR IN THE IMMEDIATE VICINITY OF: 8396 NW 195TH TERRACE HIALEAH FL 33015.

ADDITIONALLY, ON AUGUST 24, 2026, AT APPROXIMATELY 1550 HOURS, I WAS CONTACTED BY MS. DIAZ, THE DECEDENTS BUSINESS PARTNER. MS. DIAZ ADVISED THAT SHE, ALONG WITH MS. RENEE HLAVATY, THE EXECUTOR OF THE VICTIMS ESTATE, HAD OBTAINED ACCESS TO THE LAND ROVER APPLICATION ASSOCIATED WITH THE VICTIMS STOLEN RANGE ROVER. THE LAND ROVER APPLICATION ALLOWS AN AUTHORIZED USER TO REMOTELY ACCESS CERTAIN VEHICLE FUNCTIONS AND OBTAIN LOCATION INFORMATION ASSOCIATED WITH THE VEHICLE. THROUGH THE APPLICATION, MS. DIAZ WAS ABLE TO OBTAIN HISTORICAL MOVEMENT AND LIVE LOCATION INFORMATION FOR THE VICTIMS STOLEN RANGE ROVER.

AT APPROXIMATELY 1608 HOURS, THE APPLICATION SHOWED THE STOLEN RANGE ROVER ACTIVELY LOCATED AND PARKED AT THE SAME LOCATION WHERE THE VICTIMS STOLEN APPLE MACBOOK HAD BEEN ACTIVELY REPORTING ITS LOCATION THROUGH THE APPLE FIND MY APPLICATION AND WHERE THE DECEDENTS RANGE ROVER SPARE KEY HAD ALSO PREVIOUSLY ELECTRONICALLY REPORTED ITS LOCATION

AT APPROXIMATELY 1641 HOURS, OFFICERS RESPONDED TO THE AREA AND LOCATED BOTH THE DECEDENTS STOLEN LAND ROVER RANGE ROVER AND PORSHE TAYCAN BACKED INTO THE CLOSEST GUEST PARKING AREA WITHIN THE COMMUNITY, APPROXIMATELY 100 METERS FROM THE OFFENDERS RESIDENCE.

A SEARCH WARRANT, SIGNED BY THE HONORABLE JUDGE CRSITNA MIRANDA, WAS OBTAINED AND SUBSEQUENTLY EXECUTED AT 8396 NW 195TH TERRACE, HIALEAH, FL 33015. BWC WERE ACTIVATED AND UTILIZED DURING THE SEARCH AND INVESTIGATION. DURING THE EXECUTION OF THE SEARCH WARRANT, AN OCCUPANT OF THE RESIDENCE, LATER IDENTIFIED AS GEYBERT ALEXANDER GARCIA, DOB 09/18/1985, HEREINAFTER REFERRED TO AS THE DEFENDANT, FAILED TO COMPLY WITH OFFICERS VERBAL COMMANDS AND ATTEMPTED TO CONCEAL HIMSELF INSIDE A BEDROOM CLOSET LOCATED ON THE SECOND FLOOR OF THE RESIDENCE. MELANY PAVON PERDOMO, DOB 11/24/2001, HEREINAFTER REFERRED TO AS THE DEFENDANT WAS LOCATED IN AN UPSTAIRS BEDROOM.

DURING THE EXECUTION OF THE SEARCH WARRANT, OFFICERS LOCATED AND IDENTIFIED NUMEROUS STOLEN DOCUMENTS BELONGING TO BOTH DECEDENTS, AS WELL AS THE KEY FOB ASSOCIATED WITH THE DECEDENTS STOLEN LAND ROVER RANGE ROVER. ADDITIONALLY, SEVERAL VALUABLE PIECES OF ARTWORK WERE RECOVERED FROM INSIDE THE RESIDENCE, INCLUDING AN ART SCULPTURE BELONGING TO THE VICTIMS AND VALUED IN EXCESS OF APPROXIMATELY \$500,000.
