This incident was captured on my BWC.

On July 6, 2026, I was dispatched to the 400 block of SW 21st St, Fort Lauderdale in reference to vandalism. When I arrived on scene I met with Trevor Persaud, he advised me that someone damaged the camera poles and cameras. The camera pole was located on the grass/median on SW 4th Ave facing northbound and southbound in between SW 21st St and SW 22nd St.

A City of Fort Lauderdale employee Martin Zidtowcai found that the cameras were down on July 6, 2026, around 0850 hours. He called Captain Jenkins about the incident, then let Persaud know about it. I took pictures of the damage and uploaded it to evidence.com. Persaud stated that the camera poles are about three thousand dollars each.

The damages on the camera poles were the poles cut from the ground and the cameras where melted and slashed. Unknown who did the damage. Persaud took the camera poles to the Fort Lauderdale Police Department. Captain Jenkins and Persaud were giving the case number for this incident.
