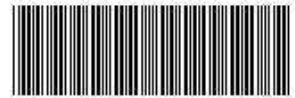

AT APPROXIMATELY 1:03PM I ARRIVED ON SCENE AND ASSUMED CONTROL OF THE ONGOING INVESTIGATION.

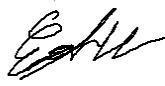
