Honorable President Donald J. Trump:

I am writing on behalf of Henry "Enrique" Tarrio, who was alleged to have been and was prosecuted by the United States Department of Justice, under the administration of Merrick Garland and President Joseph Biden, because of the events of January 6, 2021, at the United States of America Capitol in Washington, D.C.. I respectfully request on my client's behalf the consideration of a full and complete Presidential Pardon for Henry "Enrique" Tarrio.

Henry "Enrique" Tarrio is a young man with an aspiring future ahead of him. He has been a successful person throughout many plights of his life including running two successful businesses prior to his current incarceration. Henry "Enrique" Tarrio was portrayed throughout the Government's case as a right-wing extremist that promoted a neo-fascist militant organization. Henry is nothing more than a proud American that believes in true conservative values. On January 4, 2021, Henry was arrested on an unrelated charge to the events of January 6, 2021, and ordered by a District of Columbia Circuit Court judge to remove himself from the area of District of Columbia and not partake in the rally that took place on January 6, 2021. Henry followed the directions of the court and removed himself from the District of Columbia and relocated to Baltimore, Maryland. Nonetheless, the Government pushed forward charging and prosecuting Henry, along with four individuals in the same trial, for expressing their freedom of expression. The Court thereafter imposed a sentence of twenty-two (22) years of incarceration, imposing the largest sentence of any January 6 defendant.

After his sentencing, Henry has been relocated from multiple federal and private prison facilities which have placed him in special housing unit ("SHU") for most of his time in custody. The significance of being placed in the SHU is important because Henry has been housed where he can only see the outside of his cell for one (1) hour a day. The remainder of the day, Henry is kept in seclusion from other inmates in his cell by himself. No individual should be housed for this extended time as it is cruel and an unusual punishment and can lead to major mental health concerns.
