UPON THE SERGEANT AND OFFICER VIERA ISSUING VERBAL TRESPASSING WARNINGS AND COMMANDS TO THE ORGANIZED GROUP TO EXIT THE PREMISES AND STAND ONTO THE SIDEWALK, THE DEFENDANT WALKED IN THE OPPOSITE DIRECTION OF THE SIDEWALK, HE CONTINUED TO WALK IN-BETWEEN THE CROWD OF PEOPLE WHILE HANDING OUT T SHIRTS. SERGEANT AT ARMS / . AND I APPROACHED THE DEFENDANT TO WHICH SERGEANT / GAVE THE DEFENDANT A VERBAL COMMAND TO EXIT THE PREMISES AS HE IS BEING TRESPASSED. THE DEFENDANT BEGAN TO ASK WHY AND DEMAND A REASON AS TO WHY HE IS BEING TRESPASSED FROM THE PROPERTY. WHILE IN THE PROCESS OF WALKING WITH THE DEFENDANT TOWARDS THE SIDEWALK THE DEFENDANT ONCE AGAIN STOPPED WALKING, REMAINING ON THE PREMISES OF THE PROPERTY AND BEGAN TO ASK WHY HE IS BEING TRESPASSED. SERGEANT AT ARMS ADVISED THE DEFENDANT THAT HE IS BEING TRESPASSED FROM THE PROPERTY AND REFUSAL WILL LEAD TO HIM BEING SUBJECT TO ARREST, THE DEFENDANT ONCE AGAIN REMAINED ON THE PROPERTY REFUSING TO EXIT, SERGEANT AND I ATTEMPTED TO PLACE THE DEFENDANT IN HANDCUFFS TO AT WHICH POINT THE DEFENDANT BEGAN TO ACTIVELY RESIST BY TENSING HIS ARMS MAKING THE HANDCUFFING PROCESS DIFFICULT, ONCE AGAIN THE DEFENDANT BEHAVIOR DISRUPTED THE EVENT. ONCE THE DEFENDANT WAS PLACED IN HANDCUFFS AND UNDER ARREST, AS OFFICER VIERA AND I GUIDED THE DEFENDANT TOWARDS MY MARKED CITY OF MIAMI POLICE VEHICLE #216742 THE DEFENDANT CONTINUED TO ACTIVELY RESIST BY ALTERNATING STIFFING HIS LEGS THEN ATTEMPTING TO WALK IN THE OPPOSITE DIRECTION.
